### Biographical Note

Earl Schultz started working for the Little River Drainage District as Resident Engineer in 1929 and from 1932-1937 he was acting lead engineer for the district since there was no Chief Engineer. In 1938, Earl Shultz was promoted to Chief Engineer, a position he held until he retired in 1975.

On April 16<sup>th</sup> 1956, with the resignation of Burl Underwood, Earl Shultz was given the job of Secretary-Treasurer for the LRDD, with no pay increase.

### Scope and Content Note

Contains correspondence with individuals, businesses, governments, and personal covering Shultz's time as Secretary-Treasurer.

**Archivists Note:** Due to the small size of the collection and the many years Earl Shultz worked for the LRDD, this collection is expected to change periodically as new material is processed.
