## **Organizational Note**

The Board of Supervisors is the five-member elected body that oversees the work of the district. A Board of Supervisors has served since the formation of the district in 1907. The board consists of: a president, a vice-president, and three supervisors. All members of the board must be landowners in the LRDD boundaries. Supervisors are elected by the district's landowners at the annual meeting in October, as vacancies arise. Supervisors may serve consecutive terms and there is no limit to the number of terms a member may serve.

The original Board of Supervisors was made up of: John H. Himmelberger, President (1907-1930); Alfred L. Harty (1907-1931); A. J. Matthews (1907-1941); C. W. Henderson (1907-1923); and Sterling Price Reynolds (1907-1964).

## **Scope and Content Note**

Materials are sorted into four series by document type and then into subseries when necessary. The largest series pertain to meeting minutes and correspondence. A small amount of committee information and other relevant records also exists. Materials are mostly arranged chronologically, though some have been sorted alphabetically.

#### **Series Descriptions**

## **Series I: Meeting Minutes**

Includes meeting attendance, resolutions, reports on claims, warrants, court cases, and finances, along with other information relating to the LRDD. The original copies of the meeting minutes were bound as ledgers; the ledgers listed first in the container list. Copies of the meeting minutes are loose pages sorted chronologically and are listed in the container listed after the ledgers. Dates of the ledgers and the copies range from 1919 to 1995. An index to the minutes from 1972 to 1995 is available, and is listed at the end of the series.

#### **Series II: Committees**

Includes lists, resolutions, and correspondence from various committees commissioned by the Board of Supervisors. Committees were made up of engineers and other employees of the District.

## Series III: Correspondence

Correspondence with the board from landowners, companies, contractors and others. Also contains appended reports, newspaper clippings, and photographs. Correspondence is organized by individual or entity communicating with the board.

#### Subseries 1: B.F. Burns

Includes correspondence to and from Burns, who served as secretary/treasurer for the LRDD from 1920-1953. Subjects include finances, land, board meetings, and taxes. Dates range from 1919 to 1950.

#### Subseries 2: Oliver and Oliver

Includes correspondence to and from the Oliver and Oliver Law Firm. The Oliver and Oliver Law firm represented the LRDD in the early days of the district. Subjects primarily revolve around court cases and other judicial matters. Dates range from 1908 to 1989.

#### **Subseries 3: Earl Schultz**

Includes correspondence to and from Earl Schultz, who served as chief engineer from 1932 to 1975 and as secretary from 1957-1975. Subjects include ditch and levee construction, finances, land, taxes, reports, and board meetings. Dates range from 1936 to 1985.

## Subseries 4: U. S. Army Corps of Engineers

Includes correspondence to and from the U. S. Army Corps of Engineers concerning topics like ditch construction, flood control, and construction contracts. Dates range from 1964-1994.

#### **Subseries 5: Alphabetical**

Includes correspondence to and from the board, arranged alphabetically by last name, concerning topics like ditch construction, maintenance, and finances. Dates range from 1945-1989.

### **Subseries 6: Chronological**

Includes correspondence to and from the board. Subjects include ditch construction, landowners, dredging, progress reports, finances, and board meetings. Dates range from 1900-2002. Missing dates may be represented in other subseries.

#### **Series IV: Other Records**

Includes miscellaneous Board records, including resolutions, annual reports, petitions, and other records. Folders are arranged alphabetically by title and dates range from 1909-1987.
