Abstract

Historical Note

The Cape Girardeau, Missouri traffic bridge was dedicated in September of 1928. The chief engineer was Percival V. Pennybacker of Harrington, Howard & Ash, Kansas City. The construction of the bridge began in 1926 and was constructed for \$1,600,000. The main span is 1342 feet long, and the eight lengths of steel extend 4,744 feet. \$400,000 was raised locally to fund the bridge. The elaborate dedication ceremony in 1928 designated the bridge as the "Gateway to the Ozarks" and included a parade and beauty queens. In 1928, it was the only traffic bridge over the Mississippi River between St. Louis and Memphis. The Cape Girardeau Bridge Company owned the bridge until the Great Depression when it went into receivership and was sold to private owners. The long-range plan for the bridge after 1949 was for it to become "toll free" and the bridge became a part of the Missouri and Illinois highway departments during 1957.

The Bill Emerson Memorial Bridge opened in December of 2003, and the original Cape Girardeau traffic bridge was scheduled for demolition in the spring of 2004.

Scope and Content

The collection consists of photographs, daily engineer journals, original hand-drawn plans for the bridge and toll house, alternate rejected designs, progress charts, Gantt charts, correspondence, financial and legal papers.

Glossary of Engineering Terms

Borrow Pits – An area of land, usually with close proximity to the project site, in which soil can be obtained for use as embankment fill on the project.

Caissons – A rectangular or cylindrical chamber for keeping water or soft ground from flowing into an excavation.

Chord Points (Top & Bottom) – 1. Points along a generally horizontal member of a truss. Usually, the extreme top and bottom horizontal members of a truss. 2. That portion of a truss the main function of which is to resist bending on the span. Bottom Chord – The lower member of a truss usually resisting tension. Top Chord – The upper members of a truss usually resisting compression.

Chord Splices – The union of two separate chord members that occurs independently from the junction of the chord with a diagonal or lateral. Usually only occurs when chord member is exceptionally long and could not be shipped in one piece.

Cofferdams – A temporary dam-like structure constructed around an excavation to exclude water. A wall-like barrier composed of driven piling constructed to surround the area to be occupied by a structure and permit dewatering of the enclosure so that the excavation may be produced in open air.

End Posts – the end compression member of a truss, either vertical or inclined in position and extending from the top chord to the bottom chord.

Falsework – a temporary wooden or metal framework built to support the weight of a structure during the period of its construction and until it becomes self supporting.

Laterals (Top & Bottom) – Cross bracing that joins each side of the truss, intended to resist lateral movement and deformation.

"M" Points – Points in a subdivided truss at the intersection of a main diagonal and a subdiagonal. Named for the M shape that the members create.

Main Diagonals – the primary sloping structural members of a truss or bracing system. The main diagonals extend from the top chord to the bottom chord.

Nominals – Truss members other than main load carrying members used mainly for bracing other members.

Portals – the clear unobstructed space of a through truss bridge forming the entrance to the structure.

Rip-Rap – Gabions, stones, blocks of concrete, or other protective covering material of like nature deposited upon river and stream beds and banks, lake, tidal or other shores to prevent erosion and scour by water flow, wave or other movement.

Stringers – a longitudinal (running parallel to the centerline of the road) beam supporting the bridge deck.

Subdiagonals – the secondary sloping structural members of a truss or bracing system. The subdiagonals extend from the top or bottom chord to a main diagonal.

Substructure – The abutments, piers, or other constructions built to support the span of a bridge superstructure.

Superstructure – The entire portion of a bridge structure which primarily receives and supports traffic loads and in turn transfers these loads to the bridge substructure.

Sways – diagonal bracing located at the top of a through truss, perpendicular to the truss itself and usually in a vertical plane, to resist horizontal forces.
